**DEFINITION OF TERMS:**

**Peddler:** A person engaged in the selling of personal property by going about from place to place or house to house to sell such property and who carries with him such property for delivery at time of sale in Hot Springs or any municipally owned or controlled park thereof, and who does not maintain a regular stock of merchandise in Hot Springs for at least six (6) months during the year in which he is peddling or soliciting is a peddler.

**Solicitor:** A person engaged in going about from place to place or house to house soliciting orders for , or offering to sell personal property for future delivery in Hot Springs or any municipally owned or controlled park thereof is a solicitor.

**Peddling from Vehicles:** No person shall sell or offer for sale any goods or merchandise from a cart, wagon, automobile, truck or other vehicle in the thoroughfares of Hot Springs, South Dakota. This section, however, does not apply to the delivery of farm or garden products where the order for the same has been placed in advance, neither does it apply to the delivery of goods sold in the regular course of an established business.

**Exception:** The bonding and licensing of solicitors and peddlers shall not apply to salesmen doing business exclusively with retailers or merchants nor to the peddling or soliciting of orders for any agricultural product or article raise or manufactured by such peddler or solicitor in this State.
