HOT SPRINGS Ordinance Chapter 16 – Regarding Transient Merchants

Section 16-3 Transient Merchant Defined:

A transient Merchant is any person, firm, corporation, partnership, association or agents of any of them, transacting a **temporary** business where goods are exposed for wholesale or retail sale at any place in Hot Springs. A “Temporary Business” is a business established for temporary operation only. A “Permanent Business” is a business operating more than six (6) months in one place by the same person.

Section 16-8 Licenses and Bonds for Transient Merchants:

No person shall engage in business as a transient merchant as hereinbefore defined without a transient merchant’s license for each structure, stand, tent, car, vehicle, booth or place used by any such merchant. A transient Merchant’s license fee shall be One Hundred Dollars (\$100) per month and no such license shall be issued for a less period than one (1) month. To obtain such a license, the transient merchant shall file in the Office of the City Finance Officer a verified application stating his name and residence; description of goods he intends to handle; the date he acquired them; and the place from whence they were last moved. With such application, he must also file a bond to said City, to be approved by the Finance Officer, in the penal sum of Five Hundred Dollars (\$500) conditioned for payment of any license fee to become due said City, should said merchant continue to operate beyond any time for which he has paid. On filing such application and bond and payment of fee in advance, the City Finance Officer shall issue a license to the applicant to do business at the place described in the application, and for the time for which a license fee had been paid in advance.
