DEFINITION OF TERMS:

Mobile Food Vendor: Mobile food vending/vendor(s) shall be defined as an activity whereby prepared food, either on-site or at other licensed food preparation facility, or beverages are sold to the general public from a food truck or food cart. This definition shall include both food trucks and food carts. This definition shall not include food and beverage delivery service.

Mobile food and beverage vendors shall:

- Operate according to the minimum public health and food safety requirements determined by South Dakota Department of Health.
- Comply with the licensing requirements of the State of South Dakota including food, sales tax, and mobile food and beverage vending.
- Provide a trash bin for public use and remove all garbage within twenty-five feet of any food truck or food cart.
- Not broadcast loud noise that results in a nuisance to the surrounding properties.
