DEFINITION OF TERMS:

Peddler: A "peddler" is a person, principal or agent, engaged in the selling of personal property by going about from place to place or house to house to sell such property and who carries with him such property for delivery at time of sale in Hot Springs or any municipally owned or controlled park thereof.

Solicitor: A "solicitor" is a person, principal or agent, engaged in going about from place to place or house to house soliciting orders for, or offering to sell property for future delivery in Hot Springs or any municipally owned or controlled park.

Transient: A "transient merchant" is a person, principal or agent, who engages in a temporary or itinerant business from temporary location or structure in the city, and who, for the purpose of carrying on such business, hires, leases or occupies any land, structure, trailer or truck for the exhibition and sale of such goods, wares or merchandise and includes the sale of any article, fruit, vegetable or farm product.
